Sheriff Casias makes his first public appearance at Tuesday's commissioners meeting



All three Las Animas County Commissioners welcomed back Las Animas County Sheriff James Casias at Tuesday's board meeting. This was Sheriff Casias' first official public appearance since he fell ill earlier this year. Many county employees', and

others in attendance embraced and welcomed Sheriff Casias back. Everyone is glad to see him back on the job. The Sheriff took no time getting back to business asking the board to approve two new vehicles for his department. Both vehicles are fully equipped at a cost of \$5,000 each. The Sheriff also said that his department would like to sell some vehicles that

they can not longer use. Casias went on to suggest that he would like to put the money of a possible sale back into a 1 cent tax to help put an initiative on the ballot. Casias also stated that his department is willing to work with the veterans, the rehabilitation center, the health district, and any other entity to get a tax on the ballot so all parties

Raton actress takes Tennessee Williams on the road to Des Moines

Raton actress Kathryn Engel will bring her one-woman show, "Two Women of Tennessee Williams," to Studio C in Des Moines Saturday evening as the featured act in the monthly Live at Studio C series of entertainments.

Engel will provide five monologues from two of Williams' most famous

ladies, Amanda Wingfield from the play "The Glass Menagerie" and Blanche DuBois from the play "A Streetcar Named Desire." The monologues will be linked by transitions provided by a narrator, also played by Ms. Engel.

She first played the characters in two different summers of summer stock theatre in Minnesota two decades ago. "They never leave you, Tennessee Williams's women," Engel

says. "When you play his women, they take up residence in you. Particularly Blanche. It's an honor to play them."

When director Michael Tillman first convinced Engel to play DuBois - he said he would only do the play if she took the role - she tape-recorded all of her character's lines. When finished, the tape ran 90 minutes; the entire play ran two hours. Blanche is in eleven of twelve scenes. Engel was

Colo. House votes to eliminate death penalty

DENVER (AP) - The Colorado House approved a plan Tuesday to eliminate the death penalty and use the money to focus on cold cases.

The measure now goes to the Senate, where it's expected to pass. Gov. Bill Ritter, a former prosecutor, hasn't said whether he would sign the bill.

The bill passed by a single vote, 33-32, after victims' relatives asked lawmakers to help with unsolved slayings.

Rep. Ed Vigil, D-Fort Garland, cast the tie-breaking vote.

Vigil said he was torn by the decision, concerned that he was voting to take away an option for law enforcement to get guilty pleas, and the moral issue of taking a life. Vigil said he also worried that relatives of victims will now expect cold cases to be solved, which he said rarely happens.

"These are false hopes," he said.

Vigil was comforted by Rep. John Kefalas, D-Fort Collins, who said he whispered under his breath, "Thou shalt not kill," as Vigil struggled with his decision and eventually cast the final vote.

The legislation would shift funds currently used to prosecute death-penalty cases to deal with the growing backlog of more than 1,400 unsolved homicides that have stymied local investigators since 1970.

Rep. Steve King, R-Grand Junction, said the legislation will pit families of crime victims against law enforcement who are frustrated with a lack of resolution.

House Majority Leader Paul Weissmann, a Democrat from Louisville, said the state should be spending money solving those cases instead of defending the only two inmates currently on death row and a half-dozen other cases that are pending.

Weissmann said the last death penalty case tried in Colorado - against Jose Luis Rubi-Nava, who was charged with dragging his girlfriend to death behind a truck - cost \$1.4 million to prosecute.

Rubi-Nava, 38, was sentenced to life in prison without parole after pleading guilty.

Weissmann said it costs only about \$70,000 to try a non-capital case.
