## Webelos travel to meet a professional artist

DES MOINES, NM – Clayton den mother Karan Bohannon needed to find a professional artist so her three young Webelos could complete their required art merit badges. She asked another mother, Angela Safranek, for ideas. Safranek called a Clayton arts group, where most of the members are older women who paint. A woman there suggested the boys might prefer Nathaniel Franklin of Des Moines because he's male, he's young, and he works with heavy metal.

The boys and their leaders and families met with Franklin at Studio C in Des Moines Saturday morning. It looked like a match made in heaven as Franklin showed his wares and fielded excited questions not only from the three Webelos and their siblings, but also from four of their parents.

Webelos is a transitional group between Cub Scouts and Boy Scouts. Participating in

## Home fire reported east of Trinidad

### C-N STAFF REPORT

Late Sunday evening the Las Animas County Sheriff's Department was called out to a house fire at 1688 County Road 85.0, east of Trinidad, off U.S. Hwy. 160.

Las Animas County Sheriff James Casias said that his office is working with the Colorado Bureau of Investigation's arson department investigating the fire. There was no word by press time on the extent of the damage to the home, or if there were any injuries caused by the fire.

Casias said the fire is still under investigation and that his office hoped to have more information by Tuesday afternoon.

On another case that the sheriff's office is handling, no information has been released concerning a 21-year-old man who was allegedly stabbed somewhere on the north side of Trinidad at about 6:30 a.m. on Feb. 25. Casias said Monday that there is no suspect information to report, and that the officer who has the report is out of the office until Wednesday.

## Serious injuries reported in Friday collision

The Colorado State Patrol is investigating a two-vehicle crash that occurred on Interstate-25, near milepost 43, approximately six miles south of Walsenburg, shortly after noon on Friday. A 2003 Toyota Sequoia was traveling southbound in the left lane when it spun into the center median. The Toyota traveled through the median and collided with a guardrail on the northbound side of the highway. The Toyota continued into the northbound lanes and was struck on its right side by a northbound 2004 Honda Pilot. Both vehicles came to rest on the northbound shoulder, with the Toyota atop a guardrail.

The Toyota's driver, 19-year-old Paul Fatur of Erie, and his passenger, 17-year-old Anna Fatur of Erie, sustained serious injuries as a result of the crash. The Honda's driver, 66-year-old Carole Olson of Richfield, Minn., sustained minor injuries as a result of the crash. Olson's passenger, 69-year-old Charles Olson of Richfield, sustained serious injuries. All parties were transported to Spanish Peaks Regional Health Center for treatment. Anna Fatur later was flown to Denver for further treatment.

Paul Fatur was cited with 3 counts of careless driving causing bodily injury and one count of failing to present evidence of insurance. Carole Olson also was cited for failing to present evidence of insurance. All parties were wearing their seatbelts at the time of the crash. Alcohol and drug use are not suspected as contributing factors in the crash.

Excessive speed for the conditions is suspected as a contributing factor; I-25 was slushy and wet at the time of the incident.

Tole artisans paint up a storm on anything except canvas

The opportunity to create, learn, enjoy friendship and hospitality is provided to students of Lorri Kuncis in her weekly tole painting class.

Tole painting is the art of decorative painting on objects such as tin, wood, utensils and furniture. This folk art began in the 18th century in New England. Design subjects include flowers, animals, birds, fruits, vegetables, geometric patterns, shapes, religious and seasonal themes, scenery or the artist's choice.

Kuncis received her teaching degree and taught elementary education in fourth and fifth grade for 13 years. This experience, combined with her product training while employed at Leaning Tree Cards, prepared her to initiate a class of her own. Her interest in tole painting began in 1990 after taking a design class at the University of Northern Colorado. She studied with a variety of instructors to broaden her knowledge of the art and continues to hone her skill. In 2005, she began teaching the craft as continuing education at Trinidad State Junior College, the Upward Bound Program and at the Sayre Senior Center. She now continues instruction in her home.

For two and half hours, students receive information on tole painting techniques and individualized instruction with the enjoyment of camaraderie. Added to that is the opportunity to exchange books and recipes and enjoy Lorri's homemade

refreshments. Lorri shares cooking tips in addition to her tole painting knowledge. She currently is working on a cookbook for publication and bakes goodies from her recipe file, then shares the goodies and the recipes.

Tole painters Sherry Bila, Rosanna Chavez, Dora Corral, Flo Garcia and Mary Nichol, all have varied art experiences prior to taking up this craft. Productions in porcelain, ceramics, pastel, oils, acrylics and quilting are among their interests.

What attracts them to Lorri's class? "It's fun! I love to paint angels and use my finished projects as gifts for my family and friends," says Corral.

Nichol says, "I like creating and learning the techniques, but the company is wonderful. I can be under a lot of stress when I come and during the session my stress melts away."

"My previous art experience is limited, but I really enjoy tole painting," Chavez says. "I paint different subjects but a Southwest theme is my favorite."

Bila has extensive art expertise, but says, "I enjoy this avenue of artistic expression." New to tole painting, Garcia says, "I've done projects in porcelain and ceramic, but tole painting works for me." All agree that the atmosphere and the camaraderie entice their participation.

What motivates Lorri Kuncis to teach the class? "I love sharing my knowledge with others and get excited when someone is excited about what they've learned."

S. Colo. courthouse closed after rocks fall

**WALSENBURG (AP)** - The halls of justice are crumbling - literally - in a southern Colorado community.

The Huerfano (WEHR'-fah-noh) County Courthouse has been closed because large chunks of rock broke loose from the building's tower late last week and fell. State officials are assessing the building and a

report is due later this week. Local court officials are looking for another location for court and probation services. People with court appearances or probation appointments this week don't have to show up at the courthouse but must call (719) 738-1040 Tuesday for more information.

Celebrities, pols benefit from Colo. ag tax breaks

**DENVER (AP)** - Goldie Hawn, Tom Cruise and media mogul Charlie Ergen are among the people benefiting from a legal property tax break because their Colorado homes and estates are categorized as agricultural land.

People can qualify for the agricultural tax rate simply by cutting hay or allowing livestock to graze on their land, even if they don't have very much to do with food production, The Denver Post reported Monday.

Cruise allows sheep to graze for brief periods each year on the land he owns near Telluride. The newspaper says the actor pays about \$400 in taxes on the 248 acres he bought for nearly \$18 million.

He pays \$11,380 in taxes on another property where his vacation home is located. Elected officials in Colorado are also paying the lower agricultural tax rate. Democratic State Sen. Gail Schwartz and

her husband pay \$54.52 in yearly taxes on 15.4 acres of meadowland in a Basalt subdivision. They bought it for \$690,000 in 2004.

"This land is doing the same thing it has been doing for 100 years. It's irrigated, it grows hay and it's completely in the heart of agricultural land in our valley. It's not a subdivision scam," Schwartz told The Associated Press.

The Post said Republican state treasurer Walker Stapleton, who has worked as a real estate investor, and a family member pay \$116 in taxes on 180 acres near Castle Rock.

A spokesman for Stapleton said he owns only 10 percent of the parcel near Castle Rock. Representatives for Hawn, Cruise and Ergen didn't immediately provide comment on their properties.

aspect by challenging the children to see how many Nathaniel Franklin works they could find.

Although Franklin has several local nature-inspired abstract paintings on display at the gallery, both he and the boys were more interested in talking about Franklin's huge heavy metal sculptures. He narrated a slideshow of some of his work, including the new sign project at the entrance to The Mandala Center. Like much of his work, this art required the use of a bulldozer.

Franklin explained to the group that he likes to work with found objects, favoring metal he finds in junkyards or scattered in pastures. Asked by Bates how he gets his ideas, Franklin responded, "That's why I like finding stuff: things in pastures or junkyards, I find cool shapes that inspire me to make something."

He combines steel with rock to create large sculptures, some of which can be exhibited indoors but most are so big they stay outdoors. The mothers present, Bohannon and Safraneck, asked questions about Franklin's fountains. The fathers,

Scott Bohannon and John Baumchen, asked questions about welding. They learned that Franklin uses a cutting torch to break a piece down for transit, then welds it back together for installation. Individual pieces can weigh up to 500 pounds.

Franklin said he began small but found himself attracted to large work. He also started with wood, but he likes metal better "because it bends into curves," which he favors. "You can steam wood and put a bend in it, but I find metal more suitable for bending into attractive curves."

Safraneck explained that the three boys have created a number of art projects to fulfill a required art merit badge; the last step in earning the badge is to meet with a professional artist and to ask questions about both the art and the career.

The Clayton group of 10 stayed two hours, riddling Franklin with questions, which didn't seem to bother him at all, judging by his frequent smiles. Boyce was happy, too: she signed up five of the children to return for art classes. They'll start with paper maché. Maybe later - much later - they'll progress to heavy metal.
